¹ J. M. Nicholas resigned as City Marshal on 2/9/1895 after initially refusing Council's demand that he do so on 2/7/1895; his resignation was recommended by the Health and Police Committee on 2/5/ 1895.

² On 6/2/1896, Charles W. Airy was elected Fire Chief, replacing George Goodman. The City Council regular meeting minutes of 8/5/1896 state that W. A. Reese was acting as the attorney of Mr. Airy, whom he represented as having been illegally removed by Council. The minutes of the Council's special meeting on 8/14/1896 mention that Airy was suing the City. Goodman was elected Chief at that meeting, by a vote of 5 for Goodman and 3 for Airy.

³ The minutes of 11/3/1897 note that City Clerk Charles E. Meuser having departed for parts unknown and having been absent from the City for more than a month and wholly neglecting the duties of the office of City Clerk, that office was declared vacant and Council proceeded to elect a City Clerk. After difficulties in balloting, Council accepted George N. Raymond's bond on 12/7/1897 and voted him in as City Clerk on 12/13/1897.

⁴ When the City temporarily switched to a Commissioner form of government in 1915 through a change in the City Charter by special election in 1915 (cf. the 1912 proposed Charter, in the Historical cabinet, and the regular Council meeting minutes of 7/1/1915), some of the titles changed. The position of City Manager was created, and the presiding council member (usually, but not always, the Mayor or the Mayor Pro Tem) was then called the President (and also a Vice President). Paragraph 8 in Article III of the City Charter of 1915 specified that the Commissioners would elect from among themselves a Mayor, who would be president of the City Council.

⁵ A City of Durango special election was held on 6/29/1915.

The municipal water and sewer services were housed in the **Department of Public Works** prior to its configuration as a standalone **Utilities Department**, which was established after restructuring in 2012 following the retirement of Jack Rogers. In general, the Manager or Director roles in Utilities have overseen the operation of the Department as a whole while the superintendents supervised day-to-day operations of their divisions (Water Treatment, Collections and Distribution, Wastewater Treatment)

Al Patscheck was the Superintendent of the **Water and Wastewater Division**, which at the time included the Water Treatment Plant as well as the Wastewater Treatment Plant. He was succeeded by Gerald Mestas. When Mr. Mestas left, sometime in the late 1980s, Jonathan Green had a brief tenure. Tom Huston served in the role during the 1990s and resigned as Manager around 2000; he was replaced by Chris Bucher as the Water and Wastewater Manager, but the position was not filled thereafter.

From 2012, when the restructuring took place making Utilities a standalone department, Steve Salka was hired as the Utilities Director, until his resignation in 2017 due to disagreements as to the management of the multi-year Santa Rita sewer plant replacement project and other matters. The first Assistant Utilities Director, appointed in 2017, was Jarrod Biggs, who currently supervises all three utilities divisions, with Levi Lloyd serving as the Director of two departments (City Operations and Utilities)--a role akin to the previous Director of Public Works.

In **Water Treatment**, during the 1990s the Water Treatment Plant supervisor was Ambrose Hickman. After Hickman retired, his successor was Mike Amato, followed by Robert Ludwig. Mr. Ludwig was succeeded by Dave Ferguson, who currently serves as the Water Treatment Superintendent.

Within Collections and Distribution, after a second stint as Acting Water and Wastewater Superintendent Mark Gallegos was appointed to the Superintendent position on October 1990. Gallegos continued until the time of his death of a heart attack in 2011 and was replaced by as the Water and Wastewater superintendent by Joe Coleman. Following the departure of Joe Coleman, Patrick Farrell filled the role of Collections and Distribution Superintendent and continues in that role today. At the Wastewater Treatment Facility, as of 1995 the Wastewater Plant supervisor was Roger Miller. Miller resigned as the Wastewater Treatment Plant superintendent and was replaced by Arlin Lieurance, who was followed by John Sandhaus in 2009. Sandhaus was succeeded by the current Superintendent, Jeff Whitman, in 2015, ending July 2019.

At first Judge Diane Knutson covered when Judge Casey was not presiding, and Judge Paul Whistler presided if neither of them was available. With the advent of the COVID-19 scenario in 2020 the number of cases appearing in Municipal Court shrank to a fraction of the pre-COVID-19 numbers, as the Court made provisions for the cited individuals to admit their guilt and pay their fines online instead of having to appear in court. Effective 1/1/2022, two judges split the task, 50/50.

¹⁵ City Council discontinued the Utilities Director position on 8/15/2017 and included the duties of that position within the duties of the City Operations Director. Thus, the directorship of the two separate departments of City Operations and Utilities reverted to just one shared director (Levi Lloyd) at that time.

On 11/10/1953, Council appointed the law firm of Emigh & Emigh as the City attorneys, and designated Alonzo M. "Al" Emigh (pronounced like "Amy") as the City Attorney and his brother Frederic B. "Fred" Emigh as the Assistant City Attorney. Their father, A. M. Emigh, was City Attorney along with B. W. Ritter in 1924-1928. Sometime between June 22 and July 6 of 1965, Fred became the City Attorney. Fred's brother, Alonzo, died in Durango in April of 1971. (Source: David P. Smith)

M. J. **Parsons** (? – to at least 4/5/1949) (he was the caretaker--that was the term in the City Council minutes of 1/22/1946—and, later, his title was manager of the Municipal Airport where the College was later built; Council increased his salary by \$20/month effective 8/1/1948) (the same 8/10/1948 Council meeting also considered the heating at the [new] City and County airport; the 4/5/1949 Council minutes mentioned both the roof on the administration building at the new airport and Parsons as the manager of the old Municipal Airport)

Karl Link [mentioned once--6/10/1952—in the City Council minutes as the former manager of the municipal airport]

Vern [or Verne] **Carlson** [the 8/31/1948 City Council minutes mention Vern Carlson as an Airport Manager at the new City and County airport, but that was in the context of his increasing Monarch Airlines' rent—the move toward the new location began in May of 1946 and the first scheduled commercial flight was inaugurated by Monarch Airlines on 11/27/1946; the minutes of the 5/25/1948 Council meeting referred to Carlson as the Monarch Airlines Station Agent; the 12/6/1973 Airport Commission minutes mention Verne Carlson as Frontier Airlines staff in Denver; thus Carlson was not the manager of the Airport *per se*.]

Charles **Murray** (effective 7/7/1942, per City Council minutes: "Mayor Fankhauser moved that Chas. Murray be appointed Airport Manager, Jack Turner as Assistant Manager and R. F. Keeling as Assistant Manager"; the end date of Murray's tenure as Airport Director has not yet been discovered in the records)

Bruce **Lund** (9/10/1946 per City Council minutes – end date not yet determined) [the Airport Commission's 6/3/1974 minutes mention Mr. Lund as knowledgeable about the use of the Airport's well since 1946]

N. P. **Parks**, Jr. (9/1/1972- 7/20/1981 [per Council meeting minutes of 9/19/1972 and 3/31/1981, but (as regards the ending date) he was listed as present at the 7/28/81 Council meeting in the role of Airport Manager]

C. Robert **Allison** (from at least 9/22/1981 to 9/1985 when he resigned) (chosen from 7 finalists as the 1st professional Airport Manager)
